### THE SECOND SESSION OF THE 54TH OKLAHOMA LEGISLATURE

### Legislature Supports Transportation Program To Completion

THE SECOND SESSION OF THE 54TH Oklahoma legislature began February 3rd and adjourned May 23rd, a week earlier than required. Governor Mary Fallin gave the final State of the State address of her first term by advocating passage of several initiatives including reducing the state income tax, state employee pension reform, salary increases for state troopers and other state employees and repairing the state Capitol building. Despite a late session legislative threat to redirect funding from the ROADS Fund to a non-transportation area of government, and a modest reduction in the overall Oklahoma Department of Transportation (ODOT) FY-15 budget, the final executive budget fully funds the continuation of ODOT's ongoing eight-year highway and bridge construction plan. The budget also protects funding for HB 2249, passed during the 2012 legislative session, to repair or replace the remaining structurally-deficient bridges on the state system by the end of the decade, and provide additional funds and recycled beams from the former I-40 Crosstown Expressway, to address deficient bridges on the county system.

The 2014 legislative session was challenging in that the tremendous progress collectively made with regards to trans-



portation funding was legitimally threatened for the first time since 2006. Each legislative session is complex and has its own personality with progress gauged in a variety of ways. Since 2006, TRUST members have been dedicated to creating a modern, safe and efficient infrastructure system that touches every corner of the state. Fortunately, we have seen marked and steady success. 2015 will bring a new legislative session, new legislators and new challenges and opportunities to improve Oklahoma's infrastructure on many levels. TRUST must continue to stand ready.

While the eight-year highway and bridge construction plan was protected by the legislature, the state of transportation funding in Washington, D.C. continues to be a concern. The Highway Trust Fund (HTF), which reimburses states for certain highway projects, was near insolvency in August before Congress appropriated enough funds to continue the program through May 2015. While no Oklahoma projects were impacted, the ongoing instability of the HTF is an issue that ODOT officials are monitoring with a close eye. If reimbursement dollars are not available, current projects on the eight-year highway and bridge construction plan could be halted and new projects delayed. In addition to the HTF, Congress must also address the future of the current two-year surface transportation authorization program known as MAP-21. MAP-21 expired September 30th, however Congress extended its funding through next May as well. Despite these federal funding challenges, Oklahoma's steady economic growth and commitment from

the legislature and Governor Fallin has positioned transportation well for the future, however modernizing Oklahoma's transportation infrastructure on all levels is a moving target. The legislature has returned transportation as a core state government priority over the past eight years. The challenge moving forward for TRUST and everyone dedicated to building a first-class transportation infrastructure system in Oklahoma is to remain committed to communicating with the legislature, governor and Oklahoma's congressional delegation to ensure transportation investment continues to remain a top priority on the state level, and that Oklahoma receives its fair share of federal dollars.

### High Profile Tulsa Projects Open to Motorists

### TWO MAJOR INTERSTATE PROJECTS IN TULSA, ONE COMPLETED AND ONE NEAR COMPLETION, have motorists in

the Tulsa metropolitan area elated. The reconstruction of the I-44/Lewis Avenue bridge corridor, a component of the \$348 million Riverside Drive to Yale Avenue widening project, has been open to traffic in all directions for several weeks while the eastbound portion of the I-244 bridge over the Arkansas River opened September 15th following a ribbon cutting ceremony sponsored by the ODOT and the Tulsa Regional Chamber. Among the officials speaking at the event were Governor Mary Fallin, Tulsa Mayor Dewey Bartlett, U.S. Deputy Secretary of Transportation Victor Mendez, Oklahoma Transportation Commissioner Pete Regan, Oklahoma Secretary of Transportation Gary Ridley and ODOT director Mike Patterson. The remainder of the \$41 million project, including opening of the westbound lanes, is expected to be completed in the spring.

#### THE FY-15 BUDGET AGREEMENT

between Governor Fallin and legislative leaders continues to limit the size and growth of government. The total FY-15 ODOT appropriation represents a 55% reduction or approximately \$11,478,892 less than FY-14. The reduction does not impact the eight-year highway and bridge construction plan. In addition, the budget allows counties to reach their full 20% allocation of motor vehicle fees in FY-15 and directs those funds to county bridge projects.

Protecting the eight-year highway and bridge construction plan equates to an annual increase of \$59.7 million to the ROADS Fund until the total increase in the program equals \$575 million. Furthermore, current law has reduced, over a three-year period, the amount of motor vehicle fees currently going to the General Revenue Fund from 29.84 percent to 24.84 percent, directing the five percent balance to the County Improvements for Roads and Bridges (CIRB) Fund. The CIRB will now be allocated 20% of motor vehicle fees, increasing its annual funding to more than \$111 million.

As of the end of 2013, 468 of the nearly 6,800 bridges on the state highway system were classified as structurally-deficient, down from a high of 1,168 in 2004. Approximately 400 of these bridges are scheduled to be replaced or rehabilitated in the next six years providing ODOT with the opportunity to focus on asset preservation, resurfacing, shoulder and other critical projects moving forward.
